Patna, dated 13 Sep, 2026

Law officers for Patna High Court have been engaged against different categories of posts such as Addl. Advocate General, Government Advocate, Government Pleader & Standing Counsel in the office of the Advocate General, Bihar High Court, Patna vide Law Department's notification no.7473/J, 7474/J, 7475/J & 7476/J all dated 10.9.2026 respectively.

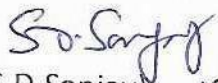
3- Law officers, whom briefs/files have been allocated herewith are requested to make contact with the office of the ex-Law officers, whose briefs/files have been allocated to them.

7-This order shall come into effect immediately.

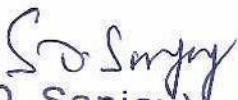

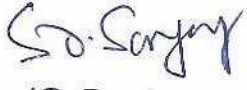
